Leaders of the communist parties of Argentina (CPA) and Chile (CPC) have addressed the CPSU CC with requests to receive in 1990 for training in security protection of the party and its leaders, including with equipment, seven representatives of the CPA and six of the CPC, and two CPC representatives as communication agents.

Leaders of the CPA and CPC explain their requests by the strengthened activity of intelligence services and the acute need in appropriately trained experts.

We would consider it possible to partially satisfy the requests of leaders of the communist parties of Argentina and Chile by receiving in 1990 five representatives of the CPA, and four of the CPC. Reception and servicing of the above-mentioned comrades might be the duty of the International Department and the Department of Affairs of the CPSU CC, and their training, assistance in documenting and special fit-out, of the State Security Committee of the USSR. Travel expenses for representatives of the CPA and the CPC from their country of residence to Moscow and back to the place of destination, including by foreign airlines, as well as their accommodation in the USSR for up to three months,
